**Application for Disaster Relief Assistance**

**Type of Assistance**

Assistance is available to qualified applicants towards documented housing, subsistence, and other needs which in the view of the oversight Committee aid the applicant in their daily needs and employment. Relief assistance is limited up to \$500 per application. Deadline for application submission is October 1, 2015. Please note this assistance is need based and other forms of assistance may be taken into consideration.

**Eligibility**

Recipient must be a full-time resident and U.S. citizen or legally admitted for residence in the United States. Applications will be reviewed without knowledge of the identity of the applicant.

**Confidentiality**

All information provided on the form will remain confidential and will be available only to those who need to confirm eligibility for assistance and to those who process the assistance to be provided. This includes providing a copy of this application to the applicant's lender or landlord, if requested. It will not be shared with other parties for any other purpose.

**Disbursement of Funds**

In order to provide for a reasonable and equitable distribution of funds, assistance will be provided on a first come, first served basis. All grants are contingent upon the availability of funds. The Illinois REALTORS® Relief Foundation reserves the right to accept or reject any application and, for good and sufficient reasons, to cancel any grant that it has made. The Committee also reserves the right to change the application criteria at any time.
